## **PROSPECTUS      CONTEMPORARY SHOW 2009**

**Entry Date:** September 5, 2009

**Receiving:** Saturday, September 5, 2009, from 9 a.m. to 10:30 a.m. **Works not accepted by the juror must be claimed between 1:30 p.m. – 2:00 p.m.** Please note that the building closes at 2 p.m.

**Gallery Hours:** Monday-Friday 8 a.m. to 6:00 p.m. (Saturday 8 a.m. to 2 p.m.)

**Juror:** Stephen Niles

**Fees:** \$20 per person for maximum of 2 pieces. Each piece thereafter is an additional \$5.00. Entry fee is non-refundable. Please ensure that you have complied with the Entry and Eligibility Rules before paying your entry fees.

**Labels:** Your entry form, art tags and payment should be prepared **before** your arrival on receiving day.

**Awards:** Best in Show, First, Second and Third Places; Three Honorable Mentions.

**Parking on Receiving Day:**

Bishop Square parking entrance is on Alakea Street, mauka of King Street. Enter the parking structure, go straight down the ramp past the guard station and turn left. Follow it around to the loading elevators. Sign in before going up to the mezzanine level to off-load your art work. You will have a grace period of 15 minutes. Park in regular parking. Saturday rates are \$4 for the day. Other parking is at Alii Place, across Alakea Street just past Starbucks.

**End of Show and Pick up Artwork:** Saturday, October 3, 2009, 8:30 a.m. to 9:30 a.m. Please be prompt. The next show has to go up. **IMPORTANT NOTICE: YOU MUST NOT FORGET TO PICK UP YOUR ART. WE HAVE NO PROVISIONS FOR STORAGE. DO NOT RELY ON US TO REMIND YOU OF THE PICK UP DAY.**

**Reception:** Tuesday, September 15, 2009; 5 to 7 p.m. Artists who are accepted into the show are asked to please bring a pupu to share.

**Eligibility:**

- This exhibit is limited to AHA members. However, we invite you to join the AHA. Please add the annual membership fee of \$30 to the entry fee when submitting your work.
- All work you submit must be original; no work produced under instruction, or copied from another's work or from copyright references will be accepted. Artwork exhibited in any previously juried AHA exhibition is ineligible.

### **Display Rules:**

- Wet work will be rejected immediately. Please, **no wet work**.
- **All works should be properly framed, wired and ready for hanging. For two-dimensional work, attach your screw eyes or hangers two inches from the top edge. Secure with wire firmly. Saw tooth hangers or other fasteners deemed to be unsafe will cause your work to be rejected.**
- Work must remain in the exhibit for the duration of the show.
- Artists with three-dimensional works must provide a dolly, if needed, and be available to assist the committee with installation.
- AHA reserves the right to refuse entry of any work for inappropriate content or presentation.

### **Sales:**

15% commission to the A.H.A. Artists discovered to have not paid the commission will be ineligible to exhibit for a period of 2 years.

### **Liability and other conditions:**

We reserve the right to reject any work for any reason, such as objectionable content. We will handle your work with the best of care. However, the AHA and Pauahi Tower gallery assume no responsibility for theft, loss or damage of any kind. Liability insurance is the artist's responsibility.

### **Paperwork: Registration and Labeling your artwork: Do Before Arriving at Pauahi:**

- Prepare the entry form in duplicate that lists all your entries. Keep one copy.
- Prepare one label per entry piece and attach it to the back of your work on the lower left hand corner. If you need more entry forms, please make a copy.
- Prepare your payments.
- When you arrive on entry day, you will be given color code "dots" to identify your painting.

### **Labeling your artwork:**

- **PREPARE YOUR ID TAGS AND FORMS BEFORE ARRIVING.**
- Entry form must be filled in duplicate. Keep one for yourself.
- Fill in an ID tag and attach it to the back lower left side of your work. If you need more forms, please make copies.
- Prepare your registration and payment before arriving. This will be a big help on entry day.

### **Procedure:**

- Prepare your I.D. tags and attach to the back of your work.
- Have all your paperwork prepared before you arrive at Honolulu Hale.
- When you fill out your entry form, please include your cell phone in case we have to get in touch with you right away.
- Make checks out to the AHA (Association of Hawaii Artists).
- Once the juror has begun his selection process, you will not be allowed to enter the exhibit. Please be prompt.
- After entering your pieces, you will be asked to leave unless you are a volunteer helping with the installation.
- Please return at 1:30 p.m. to see if your work was accepted.
- Contact Anthony Randall if you should have any questions.

**Other Things to Remember**

- Artist will not be allowed to register once the Juror has begun his judging.
- Artists will not be allowed to browse while Juror is judging.
- Artists will not be allowed to browse during installation of the art works.
- When preparing your titles, we will print EXACTLY what you write.
